Dear Colleague:

If you are receiving this communication, your organization has CY2023 ORYX Performance Measurement Requirements to submit chart-abstracted and/or eCQM data to The Joint Commission via the Direct Data Submission Platform (DDSP).

The DDSP chart-abstracted measure (CAM) module opens 12:00 pm Central Time on July 31, 2023.

- The CAM module will open for 1Q and 2Q data entry on July 31, 2023
 - The deadline to submit 1Q and 2Q CAM data has been extended to December 31, 2023.
- The CAM module will open for 3Q data entry on September 1, 2023
 - o The deadline to submit 30 CAM data is December 31, 2023
- The CAM module will open for 4Q data entry on November 1, 2023
 - o The deadline to submit 4Q CAM data is March 31, 2024
- The CY2023 eCQM module will open September 1, 2023
 - o The deadline to submit CY2023 eCQMs is March 15, 2024
